#### 2. PUBLIC COMMENT

Connie Ford provided comments as a member of the Vineyard Community Planning Advisory Council (Vineyard CPAC) regarding its nomination for the Agriculture-Residential (Ag-Res) board member to the Groundwater Authority. Ms. Ford indicated that misinformation was presented to the Vineyard CPAC members that indicated the Ag-Res Board member for the Groundwater Authority must be the Chairman of the Vineyard CPAC. Ms. Ford stated that the acting Vineyard CPAC Chair was using his position to justify renomination to the Groundwater Authority Board and to emphasize that no one else on the Vineyard CPAC is familiar enough with the issues that they could serve. Ms. Ford said that this issue is further complicated because of the Chair's term on the Vineyard CPAC has expired and that he has not been formally reappointed by the Sacramento County Board of Supervisors (BOS). Additionally, Ms. Ford stated that she did not believe that there was any consultation regarding the nomination with other surrounding CPAC's as required per Section 7 of the Groundwater Authority's JPA "Appointment of Members of Governing Ms. Ford communicated that the Ag-Res representative's presence on the Groundwater Authority Board was of particular importance when considering the three proposed master plans for new growth areas within the Central Basin are currently under review by Sacramento County. Ms. Ford felt the nominee for the Ag-Res representative should be someone who will pay attention to the issues and ensure that they're melded adequately with the responsibilities and programs charged to the Groundwater Authority. Ms. Ford declared no interest in pursuing nomination for the position, but expressed concern that the rules for nomination and appointment were not being followed. Ms. Ford said that if the BOS and the Groundwater Authority choose to change the rules, she would not object, but it was her feel that the current rules were in place for sound reasons. Ms. Ford believed it's in the public's best interest to follow them as written.

#### 3. CONSENT CALENDAR

The draft meeting minutes for the September 12, 2012 Board meeting were reviewed for final approval.

## 4. ELECTION OF OFFICERS

After a brief discussion Mr. Peifer was nominated to serve as Chair and Mr. Kamilos was nominated to serve as Vice-Chair for the calendar year 2013.

**Motion/Second/Carried** – Mr. Schubert moved, seconded by Mr. Williams, the motion carried unanimously to elect Mr. Peifer as Chair and Mr. Kamilos as Vice Chair of the Board of Directors of the Sacramento Central Groundwater Authority for calendar year 2013 in accordance with Section 3.06(a) of the Rules of Procedure.

## 5. GROUNDWATER BANKING PROJECTS

Mike Tognolini of East Bay Municipal Utilities District (EBMUD) presented perspectives, interests and potential needs in groundwater banking along with possible source water and Mr. Tognolini addressed EBMUD's partnership with the partnership opportunities. Sacramento Water Agency (SCWA) for supplemental water supply via the Freeport Regional Water Authority (FRWA). Mr. Tognolini stated that the source of the FRWA water supply is Central Valley Project (CVP) contract water through the Bureau of Reclamation that would act as dry year supply for EBMUD and normal/wet year supply for SCWA. This supply is triggered when EBMUD's total system storage is projected to fall below 500,000 acre feet which they assume would occur three years out of ten which therefor results in the potential for unassigned capacity in the FRWA conveyance system. EBMUD recently completed an additional study that projects out to the year 2040 in order to determine its long term water needs. The report showed that there is sufficient water supply for normal and wet years but the supply needed over a three year drought planning sequence of up to 115,000 acre-feet, exceeds the CVP and Freeport capacity. EBMUD would need to identify additional water supply for dry years. EBMUD has developed a preferred portfolio that identifies various projects in combination with an aggressive water conservation and water recycling program to address the drought scenario demands. Mr. Tognolini stated that even with conservation and recycling measures in place, there would remain a need for additional water supplies. To further address this, EBMUD has identified groundwater storage in its local basin, local surface water storage, water transfers and other groundwater banking opportunities as possible remedies. Potential sources of recharge water would be water transfers from the Sacramento River Basin upstream of the Freeport diversion and any available excess local, State, or federal water supply. The excess supply could be diverted through Freeport facilities for percolation/injection/in-lieu projects within Sacramento County. Mr. Tognolini stated that EBMUD was open to any of those scenarios which might utilize its excess capacity in Freeport facilities depending on what a local entity would be interested in. Mr. Tognolini stated that EBMUD would also be interested in cost sharing opportunities then further stated that for any of the scenarios to occur, a water accounting framework would need to be in place. Mr. Bettis asked what the 30-year goal for conservation would be and Mr. Tognolini reported that there was no set number and if he had to guess he would say the goal would be to lower 120 GPD to 105 GPD. It is their hope that the conservation program would save 39 MGD by 2040. Mr. Peifer asked where the source of the percolated water in the wet years would come from. Mr. Tognolini said the source would be through a transfer, upstream agencies or excess Bureau water, but more likely water from other agencies. Mr. Madison asked about their exportation of groundwater through their ordinance seems a little

ambitious. Mr. Madison wanted their perspective on how such a transaction would work in Sacramento County given their experience in San Joaquin County. Mr. Tognolini replied that he didn't think there was a connection on what's achievable in San Joaquin and Sacramento County. We can certainly look at groundwater banking programs in both counties. Mr. Bettis questioned whether or not they were looking at additional surface storage. Mr. Tognolini said there was still some surface storage available at the Pardee Reservoir and that particular project isn't needed in the 2040 timeframe.

### 6. EXECUTIVE DIRECTOR'S REPORT

- a) CASGEM Program Update: Mr. Eck provided a small update saying staff completed groundwater monitoring for fall 2012 and in the process discovered that two wells previously identified as part of the CASGEM program had been destroyed. Staff does not believe that the loss of these wells will impact the program and is working with DWR to amend the monitoring plan accordingly. The map attached to the board packet shows the location of these wells. Mr. Schubert asked if these wells were domestic supply wells and Mr. Eck responded yes.
- b) General Waste Discharge Requirements for Aquifer Storage and Recovery Projects that Inject Drinking Water into Groundwater: SWRCB approved discharge requirements on September 19, 2012 that would allow direct injection of treated drinking water into the groundwater basin. The City of Roseville has been trying for a number of years to get their ASR wells permitted and this action by the state should allow them to do so. This action by the state provides another avenue for storing water in groundwater basins.
- c) Nominations and Appointments to the SCGA Board: The only stakeholder groups pending re-nomination are Agriculture and Ag-Res; their appointments expired on September 30, 2012. Staff has been working with these groups to secure a nomination so that they can be approved by the Board of Supervisors.

#### 7. DIRECTORS' COMMENTS

Mr. Bettis asked about the recently approved General Waste Discharge Requirements for Aquifer Storage and Recovery Projects that Inject Drinking Water into Groundwater and if it's portends more state regulation with regard to groundwater. Mr. Eck said the Legislative Analysis Office (LAO) had issued a report that described a process of regulatory measures that would eventually lead to more regulatory control of groundwater by the state [Note: Refer to Groundwater Authority Agenda Board Package dated May 12, 2010 for Liquid Assets: Improving Management of the State's Groundwater Resources (LAO, March 24, 2010) and California Water: An LAO Primer (LAO, October 2008)].

Mr. Schubert stated Golden State has completed drilling some new wells and that the destruction of two previously contaminated wells has begun. No perchlorate was detected in the new wells.
